### SECTION 4 – FIRST AID MEASURES

- In case of eye contact : Flush eyes under eyelids with plenty of cool water for at least 15 minutes. If irritation persists, seek medical/advice attention.
- In case of skin contact : If irritation persists, wash with water.
- If ingested : Contact a physician or Poison Control Center immediately. Do not induce vomiting never give anything by mouth to an unconscious person.

Contain spillage, and then collect with non-combustible absorbent material (e.g., sand earth, diatomaceous earth, vermiculite) and place in container for disposal according to local, state, and federal regulations (See Section 13). Flush away traces with water. For large spills, dike spilled material or otherwise contain material to ensure runoff does not reach a waterway.
